6. Remissions and Voluntary Contributions

The Governing Body is required to determine policies for (a) making charges for school activities (b) remitting such charges.

Where education is provided for registered pupils outside school hours and is not required as part of the National Curriculum or religious education, such education is defined by 1988 Education Act as an "Optional Extra" and charges may be made.



Charging

Charges will be made for optional extras and will include an element for:

- ♦ A pupil's travel costs
- ♦ A pupil's board and lodging costs
- Materials, books, instruments or other equipment costs
- ♦ Non-teaching staff costs
- ♦ Entrance fees to museums, castles, theatres, etc.
- ♦ Insurance costs
- ♦ Teaching staff costs, including the cost of travel and board and lodging where a teacher has been engaged specifically for the purpose of providing the activity.

The charge levied for each optional extra will not exceed the total cost of the activity.

The cost of an optional extra will be determined on the basis of the cost to each individual pupil participating in the activity. The amount of any charge shall be payable by the parent or guardian of the pupil concerned.

In all instances where a school activity involves pupils in nights away from home, a charge will be levied to meet the cost of board and lodging, except in those cases where the Remission Policy is applicable.

Statutory Remissions

Parents in receipt of income support may not be charged for board and lodging for participation in a residential visit which is provided specifically to fulfil statutory duties under the National Curriculum.

Other Remissions

A parent can apply to the school for a discretionary partial or total remission of charges in cases of hardship.

Voluntary Contributions

The existence of the school's policies on charging and remissions does not prohibit voluntary contributions being sought for the benefit of any school activity.

Should the school make a request or invitation for voluntary contributions, there is no obligation for parents to contribute and their child will not be treated differently accordingly.

If the school decides to put on an activity that could not be funded without voluntary contributions, it shall not be under any obligation to provide that activity should the level of voluntary contributions received make the activity financially non-viable.

Third Party Activities

None of the provisions of these policies will apply where a third party levies a charge directly on parents in return for services provided.



Music Tuition

Where individual tuition is provided for a pupil, except as part of the syllabus for a prescribed public examination, or as required by the National Curriculum, whether inside or outside school hours, a charge is made. Such charges also include the cost of the teacher providing the lesson as well as the cost of music, the hire and insurance of the musical instrument and allied tuition, such as ensemble playing.
